Methodology

National Survey of 1,200 Likely 2020 Voters General Election

- ▶ Interviews Conducted March 20 -28, 2019
- ► Margin of Error +/- 2.8%
 - ► (Higher for Subgroups)

Jobs, Safety And Long Term Costs Are Key Factors Driving Support For Action On Infrastructure




Voters Overwhelmingly Support Buy America Laws And Proposals To Strengthen Them

Most Have Not Heard That Much From The President On Infrastructure Or Buy America – And Less From Congress






By Over 4:1, Voters Want Taxpayer Funded Projects Built "Buy America" Rather Than The "Lowest Bidder"

Which comes closer to your point of view?

Infrastructure projects paid for with taxpayer money should be built by American workers, using American-made products.

Infrastructure projects paid for by taxpayer money should be built by the lowest bidder, regardless of where the low bidder is getting their products from.



Even When Private Funding Is Used, Three-Quarters Want "Buy America" Like Any Other Public Project

Some people have proposed privatizing some infrastructure projects where private companies would invest money in exchange for the right to make a profit from it. Which comes closer to your point of view?

Private investors should be held to the same laws requiring the use of American goods and workers as are all other public projects.

Private investors should be allowed to use foreign-made goods just as they would in any business.

Voters Favor Proposals To Strengthen Buy America Laws

Ensuring All Projects And Products Are Covered, And Waivers Stopped Are Popular

Make sure <u>all materials</u> used in these projects are held to same BA standard: incl <u>lumber</u>, <u>plastic</u>, & other goods - as well as iron & steel

Make sure all types of infrast. projects...held to same BA standard: incl pipelines & energy infrastructure- as well as roads & bridges


Ensure products marked as "American-made" are not just assembled here with foreign parts and components



Most Have Heard At Least Some About Trump Addressing Infrastructure Or Buy America, But Much Less About Congress


Barely One In Ten Have Heard A Great Deal About Either Party In Congress Doing Something

How much you have heard about ____ addressing the issue of **American infrastructure**?















How much you have heard about ____ working to promote "Buy America" policies to increase the use of American goods and materials in gov. projects?
